#### Management Discussion of Fund Performance

Green Zone Capital Asset Management is pleased to provide you with the Management Report of Fund Performance ("MRFP") for the 'Total Assets Under Management' managed by the fund from the originating inception date of 2019 to current. You or your financial advisor can use this information along with the annual performance and additionally requested financial statement reports of the Fund to assess the Fund's performance and how your investment in the Fund will align with your overall financial plan.

GZC Brokerage and Investment accounts are created and managed using Coinbase and Cryptocom, cryptocurrency exchanges in which assets are bought and sold in which will then be accurately recorded using CoinMarketCap. We use CoinMarketCap alongside our spreadsheet softwares to track prices, charts, and market capitalizations of various cryptocurrencies.

#### **Investment Objective and Strategies**

The investment objective of the Fund is to provide long-term capital growth by precisely investing in very premature dollar to value assets.

Our buy and hold strategy stems from early entry points while dollar cost averaging to lower the overall average entry price. Our goal is to replicate this process to the largest extent, with a steady outpacing of the S&P 500 Index by over 500% or 5x. Under normal market conditions, the Fund will primarily invest in cryptocurrency assets. The S&P 500 Index is a float-adjusted market capitalization-weighted index of securities of 500 of the largest U.S. public issuers provided by S&P Dow Jones Indices LLC. The Index is commonly used as a measure of broad U.S. stock market performance. In order to keep a steady pace of 500% above the S&P, we focus on crypto assets which tend to showcase returns of over 300% per coins total growth.

The Fund's current principal investment strategy is to invest periodically at support/resistance levels for the assets in our current pool and employ a replicating strategy to improve ROI.

#### Risk

Risk to Reward for all selected assets will be set at a minimum of 3:1 ratio. Risk threshold must remain at this ratio with a trailing stop loss to mitigate rapid or unexpcted movements that can equate to performance drawdown.

#### **Recent Developments**

Effective January 30, 2024, Conference Calls will be held on Zoom Conferences with an optional recording feature.

Effective February 1, 2024, Introduced Tiered Performance Fees allowing a 10% Fee to drop to a minimum of 5% if eligible.

#### Trustee, Manager and Portfolio Advisor

Green Zone Capital, is the trustee, manager, and portfolio advisor of the Fund and is responsible for the day-to-day administration of the Fund. The Fund pays performance or management fees to Green Zone Capital as consideration for its services. In addition, Green Zone Capital and/or an affiliate, as applicable, acts as trustee or manager of any assets in which the Fund invests.

The Fund is permitted to purchase, sell and hold securities of certain issuers that are directly or indirectly related to Green Zone Capital.

#### **Management Fees**

The management fees are calculated based on performance with a 10.00% performance fee placed only on successful and profitable withdrawals. The fees are accrued per withdrawal and are generally paid to the Manager as a withdrawal fee, fees can only be paid when Investor agrees to confirm a profitable withdrawal from portfolio. In addition, Green Zone Capital and/or an affiliate, as applicable, is entitled to receive management/performance fees for acting as trustee or manager of any Crypto assets held by the Green Zone Capital Fund.


Green Zone Capital has adjusted the management fee system to introduce Tiered Performance Fees. We offer lower fees based on the size of a clients investment and eligibility. Investments below/under \$100,000 are subject to 10%. Larger investments between \$100,000 - \$149,999 will be subject to 7.5%. Any investments above \$150,000 will be capped off at the performance fee of 5%.


